This is to bring to your kind notice that 14 Unions and Associations have represented vide letter (1) dated 22-11-2013 that Pay and Allowances agreement reached on 31-03-2010 expires on 31-03-2014 and New wage Agreement is to be concluded before 01.04.2014. It was requested to formulate the Pay Revision Negotiations Committee before end of November 2013 for initiating the process and finalization early.

Again all the Unions and Associations represented vide letter (2) dated 18-12-2013 to form the pay revision negotiation committee before the end of December 2013 lest all the Unions and Associations will resort to agitational approach without further notice.

Even after two requests duly giving sufficient time, the management did not appoint the Pay Revision Committee so far.

Therefore all the Unions and Associations representing the entire work force right from the contract worker to the Chief Engineer level, Accounting Staff, P&G Secretariat employees have formed a Joint Action Committee for wage revision and

other important issues and to take all necessary steps to resolve the same. The Joint Action Committee requests to finalise the issues before the announcement of General Election Notification and also AP State bifurcation which will create impediment for finalisation before 31-3-2014.
