GENERAL COUNCIL MEETING 20.7.2015 RESOLUTIONS

Message dated 13.7.2015 was issued to conduct Emergency General Council meeting on 20.7.2015 to deliberate on

- Option Process to be followed during bifurcation of employees.
- 2. Conducting of Elections.
- 3. Any other issue with the permission of chair.

Accordingly APSEB Engineers' Association conducted General Council Meeting on 20.7.2015 at Vidyut Bhavan, APSEB Engineers' Association Guest House, Somajiguda, Hyderabad and discussed the issues. The Branch Secretaries of Anantapur, Kurnool, Kadapa, Tirupathi, Nellore, Visakhapatnam, Vizianagaram, Dr Narla Tata Rao Power Station, Vijayawada, Rayalaseema Thermal Power Plant, Muddanur, Sri Damodaram Sanjeevaiah Thermal Station, Nellore, Lower Sileru Hydro Power Station and Vidyut Soudha, Company Secretaries, Vice-Presidents, Executive Members and Central Office bearers attended the meeting. The following resolutions are passed Unanimously.

1. All the Office bearers condemned the action of unilaterally relieving of the 1252 employees by the Telangana Power Utilities stating that they are Andhra Native. All the Office bearers appreciated the efforts of APSEB Engineers' Association and expressed happiness and satisfaction in the efforts put forth by the Association for restoration of services of 1252 employees relieved by Telangana power Utilities illegally on 11-6-2015 with a back dated orders of 10-6-2015. It was explained about the situation of the some of the employees who are branded as Andhra Native and the approaches made to the constitutional authorities like the Governor, Hon'ble Chief Minister, Chief Secretary, Energy Secretary, CMDs, Home Department at Delhi, Sri Venkaiah Naidu Garu, Hon'ble Central Minister and Sri Sujana Chowdary, Central Minister, Hon'ble Home Minister, CPI Secretary, AIPEF functionaries and the press. The General Council passed the resolutions unanimously and authorized the central body to take all the necessary steps of approaching State Government, Ministers, Central Government and even approaching the Supreme court of India for restoration of services of the relieved 1252 employees. Further the General Council authorized to meet the expenditure incurred by the central body in

this regard in going to Delhi or any other related expenditure including legal expenses in the Supreme Court as per the exigencies till the re-instatement of the 1252 employees.

- 2. All the members present in the meeting unanimously accepted to raise funds from all the members of the Branches to help financially to the relieved employees on returnable basis, for which a committee will be formed by the central body which will take the full responsibility of collecting the money from the Branches and issuing cheques to the needy and collecting the money back after their re-instatement and returning the same to the members who have contributed.
- **3.** The General Council unanimously passed a resolution to postpone the elections till the option process is finalized and the CEC is authorized to take decision at the appropriate time.
- **4.** Efforts shall be made by the central Body for getting the additional posts sanctioned in all the AP Power utilities, keeping in view of the work load norms.
- **5.** Anantapur and Kurnool Branches have raised the issue of non sanction of Housing and vehicle loans to them, which shall be taken –up with their management.
- **6.** The long pending issue of EPF to GPF facility with a provision for pension is to be taken up with the A.P. State Government and the Management .
- **7.** SDSTPS branch raised the issue non-sanction of BOE increment to some of its members , which shall be taken-up with the APGENCO management.
- **8.** Kurnool Branch brought to the notice that SCT make PTs performance is very bad and they are harmful to the safety of field engineers as they are blasting. This is to be brought to the notice of the APTRANSCO management for immediate replacement.
- **9.** Conveyance allowance is got to be sanctioned in SDSTPS on par with RTPP & VTPS by talking to their local management.
- 10. In view of the huge stagnation in AP Power Utilities, Time Bound Promotions with financial Benefit shall be introduced to motivate the employees for getting rid of the discontentment and improving the efficiency of the Organisation.
