GENERAL COUNCIL MEETING 18.3.2015 RESOLUTIONS

Accordingly APSEB Engineers' Association conducted General Council Meeting on 18.3.2015 at Vidyut Bhavan, APSEB Association Guest House, Somajiguda, Hyderabad and discussed the issue of conducting of Elections. The Branch Secretaeries of Anantapur, Kurnool, Tirupathi, Nellore, Vijayawada, Rajhmundry, Guntur, Visakhapatnam, Srikakulam, Dr Narla Tata Rao Power Station, Vijayawada, Rayalaseema Thermal Power Plant, Muddanur, Sri Damodaram Sanjeevaiah Thermal Station, Nellore, Lower Sileru Hydro Power Station and Vidyut Soudha, Company Secretaries, Vice-Presidents, Executive Members and Central Office bearers attended the meeting. The following resolutions are passed Unanimously.

1. All the Office bearers appreciated the efforts of APSEB Engineers' Association and expressed happiness and satisfaction in getting very good Pay Revision - 2014. Further some other long pending issues like pending PG increments and conveyance allowance is also solved.

2. Conducting of Elections for the term 2015-17:

Since the present Body is adhoc body and Elections are to be conducted with in one year of its formation. In the General Body meeting conducted on 30-12-2014 at Vijayawada, it was resolved to continue the present Body till option process is completed and the Central Executive Committee will take decision at the appropriate time. However is again put forth before the General Council for a decision.
