General Body Meeting conducted on 30-12-2014 at Vijayawada

APSEB Engineers' Association General Body Meeting was conducted on 30-12-2014 at S.V.S Function Hall, Vijayawada . The diary — 2015 inauguration function was conducted on a Grand scale. Sri K.Ranganatham, Advisor to Secretary Energy, AP State Government released the Engineers' Diary, Sri HY Dora, CMD / APSPDCL released the wall calendar and Sri AV Rao , Director (HR), APGENCO released the Table calendar. About 800 engineers belonging various branches in AP State pertaining to APGENCO, APTRANSCO, APSPDCL and APEPDCL attended the function. Later APSEB Engineers' Association General Body was conducted and the following resolutions are passed unanimously.

- a. Diary Fund by each Branch: All the branch office bearers were requested to send the Diary fund early.
- b. Forming of Building Committee for the Guest House to be constructed at Vijayawada: It is resolved to open a separate account for Building fund at Hyderabad. Building committee will be formed by the CEC and Building execution committee will be formed involving VTPS and Vijayawada members such that they can supervise the work progress on daily basis.
- c. Building Fund of Rs 3000/- per member to be collected by respective branch secretaries by 30th Jan. 2015. : It is unanimously resolved to collect Rs 3000/- per member by the branch secretaries in the month of January 2015 to the building fund for the Guest Houses to be constructed at Vijayawada and later at Visakhapatnam. The branch secretaries will transfer the fund to the Central account created for

the purpose. The Branch Secretaries of Guntur, Nellore and kadapa also proposed to construct/ renovate Guest Houses in their Branches.

- d. Conducting of Elections for the new Body: Majority of the branches opined to continue the present adhoc body till option process is completed. However, Elections are to be conducted at the appropriate time as decided by the CEC. Preliminary work like the valid members list along with their Employee Id and mail Id shall be collected by all the branch secretaries within one month and forward to the central body. Till the new body is elected, the present adhoc body shall continue the activities.
- e. New Medical Scheme to be implemented: New cash less medical scheme is to be designed in co-ordination with all the unions and Associations. Central Body may take suitable necessary action in the matter.
- f. Option process: All the necessary steps required to safeguard the service interests of all members of Association during option process shall be taken.
- g. Service Weightages to AEs of 2005 batch who were denied in the PRC 2006: This issue is to be taken-up on priority and orders are got to be issued.
- h. PG Increments to such of those members who were not issued 'NOC' certificate but completed before the cut-off date. This issue shall also be persued to the logical end and orders got to be issued.
- i. EPF to GPF conversion and pension facility for the AEs recruited after 1999: This is a long pending issue. Efforts to be put to resolve this issue amicably.
- j. Creation of Additional Posts: It is well known fact that APSPDCL and APEPDCL is lagging behind promotions, there is heavy stagnation and the engineers are getting de-moralised. Therefore sanction of additional posts are to be taken-up on priority.
- k. Recruitment of AES: There are lot of vacancies in the AE cadre in all the Four entities. The recruitment of AEs shall be taken-up as early as possible.
