3. Elections to be conducted:

The General Body, CEC and General Council has already discussed this issue on earlier occasions in the meetings and authorized the CEC to conduct Elections at appropriate time after option process.

But it is noted that, the option process is getting delayed and cannot be assumed a fixed time frame for completion due to relieving of employees issue pending in court of law and delay in formation of Bifurcation Committee to frame guidelines. The Adhoc Body is functioning since one year & three months. Some of the CEC members wanted to continue same body till option process is completed. But majority of members opined that adhoc body should not be continued for long and Elections shall be conducted at the first opportunity in democratic manner.

Therefore majority of the CEC Members felt that Election Process may be initiated immediately after payment of arrears/salaries of the 1253 relieved employees by Telangana Power Utilities as Option process will take some more time. Meanwhile the existing body will be continuing the Association activities as usual till new elected body is available. Sri B.V.R Prasad, DE / APGenco is nominated as the returning officer for conducting Elections. The CEC will hand-over the Association Bye-laws copy, General Body resolutions Dtd.14.06.2014 and valid members list to the Retuning Officer. A team to assist Returning officer will be formed by taking one or more members from APTransco, APGenco, APSPDCL and APEPDCL as per the need to complete the task.

4. Superannuation Age:

Majority of the CEC members expressed that the enhancement of superannuation age shall be done after option process is completed as APSPDCL and APEPDCL Engineers are suffering due to lack of promotions due to stagnation. It is felt that the enhancement of age may adversely affect the option process as more number of people opt AP due to enhanced service.

5. Financial Assistance:

The CEC has unanimously resolved to contribute Rs 1000/- per member towards contribution for legal expenses to help the relieved employees in case the legal battle going to Supreme Court.
