b. One Association for Telangana State with a new name, for all the engineers in Telangana State who were members of APSEB Engineers' Association from the cadre of Assistant Engineer to the Executive Director Cadre and the other Association for Residual Andhra Pradesh State with a new name for all the engineers in Residual Andhra Pradesh State who were members of APSEB Engineers' Association from the cadre of Assistant Engineer to the Executive Director Cadre. The present APSEB Engineers' Association will be a apex body which will co-ordinate both the States' Association for few more years till all the issues arising out of bifurcation between two States are resolved.

The Company Office bearers and branch Office bearers are requested to deliberate on the above issues with their members and give suggestions for further discussion. All Further modalities, issues, name of the successor Associations, structure, functioning, sharing of Assets etc., will be discussed and decided in the General Body, to be convened later.
