RESOLUTIONS OF GENERAL BODY MEETING CONDUCTED ON 15-9-2013.

APSEB Engineers Association General Body meeting is conducted on 15.09.2013 from 10.30 AM onwards at Vidyut Bhavan, APSEB Engineers' Association Guest House, Simajiguda, Hyderabad.

46th Engineers' day was celebrated on the eve of Bharat Ratna SIR Mokshagundam Visveshwaraya on his 153th Birthday.

The 2 year tenure of the present body is completed by 15.07.2013. The Central Executive Committee Meeting (CEC) conducted on 04.08.2013 resolved to appoint a Returning Officer by conducting a general council meeting on 25.08.2013. Accordingly all Branch Secretaries were informed to conduct Branch Meetings and appraise the members about conduct of elections. However the General Council Meeting could not be conducted due to the disturbances in the State because of the proposed bifurcation of the State. The Returning Officer and his team is identified (Sri Bikshapathi, SE / APCPDCL, Sri B.V.R. Prasad, DE / APGENCO, S.Sreenivasan, ADE / APTRANSCO and Eswar Prasad ADE / APCPDCL) and the team is announced in the General Body Meeting for approval. The General Body then deliberated conduct of Elections critically due to the disturbances in the State and felt that conduct of Elections peacefully may not be possible at this juncture.

The General Body passed the following resolutions unanimously.

1. To extend the term of the present body by one year i.e. upto 15.07.2014 as per the Bye-laws of the association.
