Sub: APSEBEA – Arriving of AE and AAE vacancies for filling up in APTRANSCO with Direct Recruitment AEs, Graduate sub-Engineers and appointment by Transfer from Sub-Engineer – Reg.
Ref: 1.Lr.No.CGM(HRD&Trg)/DE(T&MPP/ADE-I(MPP)/A1/1077/2010, dt.09-11-2010.

This has reference to your letter dt.9-11-2010 on the subject matter for absorbing 86 eligible Sub-Engineers from DISCOMS duly keeping vacant adequate number of AAE posts already working in APTRANSCO.

You may recall the discussions that were held some time back to fix up ratio among AEs and AAEs cadre based on the existing posts. The management is kind enough to resolve similar issue by fixing ratio in DISCOMS. In the same way the ratio between AEs and AAEs shall be fixed in APTRANSCO at an early date. After fixing up of ratio in APTRANSCO, the absorption of 86 eligible Sub-Engineers can be examined.

Therefore, it is requested not to issue any orders for filling up of vacancies from the eligible sub-engineers of DISCOMS till the ratio is fixed.
