RESOLUTIONS OF THE EXTRA-ORDINARY GENERAL BODY MEETING CONDUCTED ON 10-10-2010

Extra-ordinary General Body Meeting is conducted on 10-10-2010 at Rajahmundry for discussing the Amendments to the Byelaws with the following agenda.

- 1. Amendment of Bye-law to enable the members, who have held two consecutive terms as office bearers to contest Elections.
- 2. Creation / Inclusion of new office bearers posts at Branch, General Council and Central Executive Committee levels.

The General Body which was attended by about 700 members, extensively deliberated the issues and the following resolutions are passed.

- (1) A secret Ballot was conducted to know the majority opinion to enable the members, who have held two consecutive terms as office bearers to contest Elections. A total of 405 members exercised their franchise. 265 members voted in favour of Amending the Bye-laws for enabling the members, who have held two consecutive terms as office bearers to contest and 140 members voted against. As per the Bye-law 16 of the Association, for amendment to take place, 2/3 members present shall vote in favour. The proposal of amending the Bye-law is not passed. General Body authorized the CEC to initiating Election Process.
- (2) The Central Body can take necessary steps for creating the additional posts of the Office bearers in Central Executive Committee, General Council and Branch level.
