Resolutions of the General Council Meeting Held on 15.9.2012.

General Council of APSEB Engineers' Association met on 15.9.2012 at APSEB Engineers' Association Guest House, Vidyut Bhavan, Somajiguda, Hyderabad and passed the following resolutions Unanimously.

1. It is proposed to bring a EXECUTIVE DIARY with a minimum contribution from each member which will be decided after finalization by the Diary Committee.
2. The company Office bearers shall pursue the replies / data pertaining to the queries raised by the Energy Department for sanction of new posts and forward them to APTRANSCO for submitting to the AP State Government. Similarly necessary steps may be taken with the respective companies for filling up of vacant AE posts through direct recruitment. If necessary they shall also seek the help of Central Body in case of any difficulty.
3. The CEC is authorized to take all necessary steps to resolve the pending issues which were promised in the form of Minutes of Meeting dt 30-4-2012.
4. The Genco Body shall conduct a GENCO General Council meeting to finalise the Transfer Policy and any other issues. The resolutions may be submitted to the Central Body for taking further necessary action.
5. The General Council approves revoking the suspension of membership of certain members on whom action was taken.
6. The APTS and Vigilance wings in APDISCOMs are created to help the field engineers during Anti-theft Operations in discharging their duties safely and effectively. It is brought to the notice of the Association that the Vigilance Wing in DISCOMs are causing inconvenience to the field engineers on anonymous letters and on some other frivolous grounds. The duties and responsibilities of the Vigilance Wing shall be reviewed and proper instructions may be issued to them so as to assist the Field Engineers for effective implementation of Policies of AP Power Sector.
7. SGP Increments shall be sanctioned for such of those engineers who were promoted 2 days earlier of their 6 years tenure but were given posting orders after completion of 6 years.
