RESOLUTIONS OF THE GENERAL COUNCIL MEETING HELD ON

31-10-2010

After the Rajahmundry General Body Meeting Conducted on 10.10.2010, many of the Branch Secretaries requested that General Council shall also be called as they could not express their opinion because of lack of time in the General Body and to discuss the Election process as they are the stake holders for conducting the Elections. The CEC has also felt that the election process has to be initiated with due deliberations with all the General Council Members as every body need to be geared up for conducting the state wide Elections. Accordingly General Council cum Central Executive meeting is called on 31-10-2010 to initiate Election process vide circular dated 20-10-2010 at Vidyuth Bhavan, APSEB Engineers' Association Guest House, Somajiguda, Hyderabad. The Branch Secretaries were also requested to come with valid members list.

All the members present opined as follows.

1. The State is passing through a very Critical phase and the Sri Krishna Committee report is expected to be submitted by 31-12-2010. The Condition of the State is Unpredictable now. Therefore the term of the present body shall be continued.
2. For resolving important issues like Time Bound Promotions & Medical policy, the term of the present Body shall be extended.
3. Thorough discussion is required for amendment of Bye-laws. There shall be review of Bye-Laws for creation of new office bearer posts, Eligibility, the tenure of the elected body, quorum for the meeting, monthly contribution towards membership.
4. For taking action of Diary – 2011 preparation and release.
