It has come to the notice that the AP Power Utilities and Telangana Power Utilities are to attend a meeting on 2.12.2016 regarding bifurcation of Assets, Liabilities and employees. In this regard the following is submitted.

- The employee bifurcation shall be taken-up first, prior to Asset and Liabilities bifurcation. The Hon'ble Chief Secretary of A.P. has already issued a letter in this regard. Further this Association opines that the relieved employees from Telangana Power Utilities will be under severe insecurity that their uncertainty may be further prolonged once the Assets and liabilities are finalized and the bifurcation issue will left forever and their mental agony will deepen further, since Hon'ble courts and political system is also not conducive for finalization of the issues.
