The Central Executive Committee of APSEB Engineers' Association met on 3-2-2013 in the APSEB Engineers' Association Guest House, Vidyut Bhavan, Somajiguda, Hyderabad, discussed all the issues pertaining to the implementation of Minutes of Meeting dated 15-12-2011 & the seniority issue of Company to Company Transfer Assistant Engineers and passed the following resolutions unanimously.

1.The CGM / HRD post in APEPCPDCL and APNPDCL shall be filled with in-service engineers.

2. The GM (IT) Post in APNPDCL and APSPDCL and GM (CSC), GM (Energy Audit) in APEPDCL shall also be filled up with in-service engineers.

3. The company secretaries are requested to make a list of issues / policies which are detrimental to the interests of their company/ power sector by 12th Feb2013 such that the same will be reviewed and a consolidated proposal will be submitted to the State Government, Energy Department and all the CMDs. The company secretaries are requested to bestow their personal attention on this.

4. The central office bearers shall be once again discussing with the managements to issue orders on the commitments made by them. If the response of the management is not encouraging and the issues are not resolved amicably by end of Feb.2013, it is proposed to hold a mass dharna by 1st week of march'2013 at VidyutSoudha, Hyderabad.
