Resolutions of General Body Meeting Conducted on 20-2-2011.

The APSEBEA Conducted its General Body on 20.2.2011 at Vidyut Bhavan, Somajiguda, Hyderabad and passed the following resolutions Unanimously.

- 1) The Amendments to the Bye-Laws as proposed by the Committee and passed in KTPS General Body Meeting held on 19.12.2010 are approved with the slight modification in the clause 8, ie.. prior experience for contesting some of the posts and restricting the members who were office bearers of other Associations for the last one year. The CEC is authorized to finalize these modifications duly taking views expressed in general body meeting in to consideration.
- 2) These amended Bye-Laws shall be communicated to Registrar of Societies for registering the same and also to election officer to conduct elections for next term.
- 3) To take all necessary steps to address the Managements on Time Bound Promotions, Sanction of Posts, Recruitment, Construction of Quarters in APGENCO and Laying of Road to RTPP and Chalk out action plan for achieving the above issues.
- 4) Er. M. Suresh Kumar, DE / DPE / APCPDCL is nominated as Returning officer for Conduct of Elections for the term 2011-13 of APSEB Engineers' Association. The CEC is authorized to nominate Assistant Returning Officers, one each from DISCOMS, APGENCO and APTRANSCO for assisting the Returning Officer. The CEC Shall also extend the necessary Logistical and other support needed for smooth conduct of Elections.
- 5) The General Body authorized CEC to initiate disciplinary action against the members who have indulged in anti association activities and also authorized CEC to constitute a Committee in this regard.
