Resolutions of CEC Meeting Conducted on 12-3-2011.

The APSEBEA Central Executive met on 12-3-2011 at Vidyut Bhavan, APSEBEA Guest House, Hyderabad and passed the following resolutions Unanimously after extensive deliberations.

- 1. Regarding the clause 8, ie. Prior experience for contesting some of the posts: It is decided that for the post of PRESIDENT, SECRETARY GENERAL and ASSOCIATE PRESIDENT, the contestant shall have the experience of one term as CEC Member or Two Terms as General Council Member. For Vice-President post, the contestant should have served as General Council member for at least one term.
- 2. The contestant shall not be an Office bearer of any other Union / Association as on the date of filing of Nomination.
- 3. The PPP mode designed in TLC works of APTRANSCO shall be rejected out-right and opposed tooth and nail.
- 4. The re-organization in APTRANSCO shall be taken-up only after sanction of posts as submitted by APSEBEA.
- 5. A committee shall be formed and assigned the work of registration of Amended Bye-laws.
- 6. Time Bound Promotions and Medical Scheme Orders shall be issued by the management immediately, otherwise the Agitation Programme shall be started by holding a dharna during lunch time at Vidyut Soudha.
