1. Under Sl. No. 3 of Annexure-II (Election Schedule) of the Notification cited at reference (1), objections on the List of Valid Nominations were receivable up to 17:00 Hrs on 21.09.2026. The objections cited at reference (3) have been received within that period. Original objections may be inspected at the RO's office before 15:00 Hrs on 22-09-2026.

2. Before any decision is taken on these objections, each contestant concerned is being given an opportunity to furnish remarks, so that the matter is decided after hearing both sides. This letter is not a finding on the merits of any objection.

3. Holding a post in a Co-operative Stores in a Generating Station (reference 3)

It has been objected that the following contestants were elected on 12-07-2026 as Directors of the Managing Committee of the VTPS Officers Co-operative Consumer Stores Ltd. No.G-2642, Ibrahimpatnam, for a term of five years, and continue to hold those posts:

The objection relies on Para (f)(ix)(c) of the Note for item (1) of Annexure-II, which provides:

“No member is eligible to become office-bearer who holds a post in other Associations / Union / Co-operative society (Stores in Generating Stations) representing the employees working in APTransco, APGenco & APDiscoms. ... However, eligibility is given to the office bearers of the co-operative societies running welfare activities and stores in the APGenerating plants / APDiscoms provided they resigned to their post held in such society before filing the nomination and proof of such resignation shall be enclosed along with nomination.”

Attention is also drawn to certification (ii) and Note (v) of the Nomination Form at Annexure-III. The contestants at Para 3 are requested to state, with documents:

- (a) whether they hold, or held on the date of filing the nomination, any post in the said Stores;
- (b) if they resigned, a copy of the resignation letter, its date of submission and the acceptance by the Stores, each bearing a date prior to the date of filing the nomination;

4. Eligibility for Secretary (Organization) and Secretary (Welfare) (reference 3)

It has been objected that the following contestants for Secretary (Organization) and Secretary (Welfare) are stationed at the Head Quarters of APTRANSCO:

As per Sl. No. 9 and 15 of Annexure-I (A) and Para (f)(iv) of Annexure-II, these two posts are open only to members working in APTRANSCO “other than its Headquarters”. The contestants at Para 4 are requested to furnish a certificate from their Branch Secretary (or) from Secretary General that the office where they are working is not part of the Head Quarters of APTRANSCO.

This objection relates only to the posts of Secretary (Organization) and Secretary (Welfare). Their nominations for other posts are not affected by it.

5. Time and mode of reply

The remarks, duly signed, shall reach the undersigned on or before 17:00 Hrs on 22.09.2026, either in person at the Office of the Returning Officer, 4th Floor, APGENCO, Main Building, Vidyut Soudha, Gunadala, Vijayawada – 520004, or as a signed scanned copy on WhatsApp to 9493120085.

6. If no reply is received within the stipulated time, or if the reply received does not establish the eligibility in question, it shall be construed that the contestant has no explanation to offer. The objection will then be decided on the material available, and the nomination(s) of that contestant for the post(s) mentioned against his name above shall be treated as invalid, without any further notice.
7. The decision of the Returning Officer on the objections will be taken in terms of Para (8) of the Election Notification and will be reflected in the final list of valid nominations to be declared on 25.09.2026.
